This roster recognizes the innovative faculty who have used a [Stone Soup Project](#) assignment in 2017-2018. This year, the project has engaged almost 1000 students in 40 classes covering 12 subjects, taught by 32 faculty from 25 schools in 3 countries.

While some colleagues have used similar assignments in the past, this Project is a collaborative effort to systematically develop knowledge and pedagogical techniques. We are in a thousand-flowers-blooming stage, when faculty are using their ingenuity to plan assignments that work best to help their students learn about actual practice.

In addition to helping educate students, we are learning from these experiments about how to better design course assignments. Stone Soup faculty are sharing insights through [assessments of their courses](#) so that we all can learn from their experiences. The website includes materials for faculty to [develop interview assignments in their courses](#) as well as other resources
